The interested bidders must inspect the vehicles physically. The mere act of submission of tender implies that the bidders accept without any question the terms and conditions attached.

### **BID FORM**

#### TERMS AND CONDITIONS

- 1. The bid form should be submitted in a sealed envelope and should be addressed to HRAD General Manager, State Trading Corporation of Bhutan Ltd, Thimphu.
- 2. The envelope containing the sealed bid must be marked as:

#### "STCBL Sealed Bid for Vehicles"

### "Do Not Open Before: 11:30 AM on 21st December 2022"

- 3. Each page of the bid form must be duly signed by the bidder. Non-signing on all the pages of bid form will result in rejection of bid.
- 4. The bid form must be submitted to the HRAD latest by 10:00 AM, 21<sup>st</sup> December, 2022 and the tender will be opened at 11:30 AM on the same day at STCBL Conference Halls in the Head Office in Thimphu and Regional Office in Phuentsholing simultaneously, and awarding of winning lots shall be done on the same day.
- 5. The bidders have to deposit an earnest money of Nu. 20,000.00 for the four-wheeler vehicle in the form of demand draft or cash warrant addressed to HRAD General Manager, State Trading Corporation of Bhutan Ltd, Thimphu along with the bid form. Any bid not accompanied by acceptable EMD shall be rejected.
- 6. The earnest money of the successful bidders will be retained until the successful bidder deposits the full bid amount. The earnest money of the successful bidder will be returned upon depositing the full bid amount.
- 7. The earnest money of unsuccessful bidders will be refunded immediately after the decision is made by the tender committee to sell the vehicle at the quoted price or not.
- 8. The earnest money of the successful bidder will be forfeited if the successful bidder does not deposit the 100% bid amount within 10 working days and the bid will no longer be valid.
- 9. The successful bidder is required to pay 25% of the tender amount at the time of acceptance of tender or the next working day and the balance amount within ten(10) working days from the date of acceptance, failing which, the offer will be cancelled and the 25% deposit shall be forfeited.
- 10. The EMD shall be forfeited if the bidder withdraws its bid after the bid opening.

- 11. It will be assumed that the bidder has inspected the vehicles and is satisfied with the vehicle condition. The items are offered for auction and will be sold "AS IS WHERE IS BASIS" without representation, warranty, or guarantee as to the quality, condition, size, or kind, or that the same is in condition, or fit to be used for the purpose for which intended, and no claim for any allowances or deduction upon such grounds shall be considered after the bid opening or bid is awarded.
- 12. Inspection of the vehicles shall be allowed strictly from 14<sup>th</sup> October to 25<sup>th</sup> October, 2022 during office hours. No inspection shall be allowed thereafter. Complaints of any mismatch of the condition of the vehicles will not be entertained later.
- 13. The vehicles may be inspected at the respective State Trading Corporation of Bhutan Ltd Office Premise during office hours.
- 14. The winning bidder shall lift all the items of the particular lots that they have won in the auction and should not leave unwanted items in the auction yards. If the unwanted items from the lots that they have won are left behind, the vehicles shall be detained by the respective STCBL premises until the unwanted items are cleared.
- 15. The successful bidder shall lift the vehicle on the day of Final Payment at their own cost.
- 16. After the final payment day is lapsed, a demurrage charge of Nu. 500 shall be imposed on every vehicle.
- 17. The successful bidder shall be liable to pay all statutory taxes and duties applicable in the Kingdom of Bhutan for the transfer of the properties.
- 18. The opening committee shall read the quoted bid amount to all the participants on the tender opening day.
- 19. No complaint from the bidder shall be entertained once the auction is completed.
- 20. If there is a tie between bidders then a lucky dip shall be held as 'YES' or 'NO' to decide the ultimate winner.
- 21. The tender committee reserves the right to accept or reject the bids without assigning any reason whatsoever. In case of misunderstanding controversy or dispute with regard to the sealed bids, the committee's decision will be final and binding.
- 22. It is mandatory for all the bidders to quote price both in figure and in words. In case of discrepancy between the figure and words, the words will prevail over figures.
