The tender shall be opened on the same day at 11:30 AM in the STCBL Conference hall at the Head Office, Thimphu and Regional Office, Phuentsholing simultaneously, followed by awarding of winning bidder. The interested bidders must inspect the vehicles physically. The mere act of submission of tender implies that the bidders accept without any question the terms and conditions attached.

TERMS AND CONDITIONS

- 1. The bid form should be submitted in a sealed envelope and should be addressed to General Manager, HRAD, State Trading Corporation of Bhutan Ltd, Thimphu.
- 2. The envelope containing the sealed bid must be marked as:

"STCBL Sealed Bid for Vehicles"

"Do Not Open Before: 11:30 AM on 22nd August, 2022"

- 3. Each page of the bid form must be duly signed by the bidder. Bid form submitted without signature of the bidder on all the pages shall be rejected.
- 4. The bid form must be submitted to the HRAD latest by 10:00 AM, 22th August, 2022 and the tender will be opened at 11:30 AM on the same day at STCBL Conference Halls in the Head Office in Thimphu and Regional Office in Phuentsholing simultaneously, and awarding of winning lots shall be done on the same day.
- 5. The bidders have to deposit an EMD of Nu. 20,000.00 (Twenty thousand only) for the fourwheeler and Nu. 1,000.00 (One thousand only) for each two-wheeler vehicle in the form of demand draft or cash warrant addressed to General Manager, HRAD, State Trading Corporation of Bhutan Ltd, Thimphu along with the bid form. Any bid not accompanied by acceptable EMD shall be rejected.
- 6. The EMD of the successful bidders will be retained until the successful bidder deposits the full bid amount. The EMD of the successful bidder will be returned upon depositing the full bid amount.
- 7. The EMD of unsuccessful bidders will be refunded immediately after the decision is made by the tender committee to sell the vehicle at the quoted price or not.
- 8. The EMD of the successful bidder shall be forfeited if the successful bidder does not deposit the 100% bid amount within 10 working days and the bid will no longer be valid.
- The successful bidder is required to pay 2570 or an of tender or the next working day and the balance amount within ten (10) working the date of acceptance, failing which, the offer will be cancelled and the 25% deposit shall after the bid opening. 9. The successful bidder is required to pay 25% of the tender amount at the time of acceptance
- 10. The EMD shall be forfeited if the bidder withdraws the bid after the bid opening

- 11. The items are offered for auction and will be sold "AS IS WHERE IS BASIS" without representation, warranty, or guarantee as to the quality, condition, size, or kind, or that the same is in condition, or fit to be used for the purpose for which intended, and no claim for any allowances or deduction upon such grounds shall be considered after the bid opening or bid is awarded.
- 12. It is the responsibility of the bidders to inspect the vehicles (auction items), thus, it will be assumed that the bidder has inspected the vehicles and is satisfied with the vehicle condition.
- 13. Inspection of the vehicles shall be allowed strictly from 10th August to 22nd August, 2022 during office hours. No inspection shall be allowed thereafter. Complaints of any mismatch of the condition of the vehicles will not be entertained later.
- 14. The vehicles may be inspected at the respective State Trading Corporation of Bhutan Ltd. Office Premise during office hours.
- 15. The opening committee shall read the quoted bid amount to all the participants on the tender opening day.
- 16. If there is a tie between bidders then a lucky dip shall be held as 'YES' or 'NO' to decide the ultimate winner
- 17. The successful bidder shall lift the vehicle on the day of Final Payment at their own cost.
- 18. The winning bidders shall lift all the items of the particular lots that they have won in the auction and shall not leave any unwanted items from the lots in the auction yards. If the unwanted items from the lots that they have won are left behind, the vehicles shall be detained in the respective STCBL premises until the unwanted items are cleared.
- 19. After the final payment due date is lapsed, a demurrage charge of Nu. 500.00 per day shall be imposed on every vehicle.
- 20. The successful bidder shall be liable to pay all statutory taxes and duties applicable in the Kingdom of Bhutan for the transfer of the properties.
- 21. No complaint from the bidder shall be entertained once the auction is completed.
- 22. The tender committee reserves the right to accept or reject the bids without assigning The with age of the state of th any reason whatsoever. In case of misunderstanding, controversy or dispute with regard to the sealed bids, the committee's decision shall be final and binding.
